- 1. Outstanding known monthly/quarterly obligations consist of the following:
  - a. Electrical for the month of May estimated \$22.
  - b. Landscaping Services for May \$1,098.20.
  - c. Reimbursement for postage stamps to Kathy \$9.80.
- 2. Outstanding accounts receivable (dues and late fees) at month end is \$1,365.20. Of this amount, \$338.52 is **90 days** in arrears.
- 3. Prepayments total \$70.32.
- 4. Statement displays beginning balance for all accounts at the top of each monthly column, the ending balance for all accounts at the bottom of each monthly column, and each month displays the breakdown of the all accounts balance by type. Additionally, the portion of dues that are allocated to reserves is now displayed as a reduction of total revenue to illustrate the operating revenue that funds TVHA operating expenses.
- 5. Three CD accounts were opened in Dec 2014 at Kitsap Bank. Two represent reserve accounts (1) asset replacement and (2) uncertainties. The third CD account represents unallocated funds.
